Add: 2. Center glazed system.

High Performance Organic Finish shall be changed to Anodized Aluminum, color: Black.

Paragraph 1.3.F.,

Clarification:

Qualified Professional Engineer's seal is required for complete curtainwall systems.

Paragraph 1.8.B.2,

Change:

Warranty Period shall be 10 years from Substantial Completion.

Paragraph 2.3.F.3,

Change:

Door Design shall read as: Wide Stile door (5.5" verticals and top, 10" bottom).

Clarification:

Thermal Doors are required at doors 107B, 108B & 208.

Paragraph 2.9,

Change:

High Performance Organic Finish shall be changed to Anodized Aluminum, color: Black.

Specification Section 08 7000 – Door Hardware,

Paragraph 3.6 Door Hardware Sets,

Hardware Set 8

Provide the following for each door:



3 Hinges, Entry Lock / cylinder w/ lever each side, closer w/ overhead stop, kick plate, threshold and weatherstripping – hardware shall be from same mfr and quality as specified for office building hardware.

Hardware Set 9

Provide the following for each door:

3 Hinges, Entry Lock / cylinder w/ lever each side, closer w/ overhead stop, kick plate, threshold and weatherstripping – hardware shall be from same mfr and quality as specified for office building hardware. Note: doors swing into building.

Stair A shall be carpeted for the entire run (CPT-2).

Clarification; Acoustical Ceiling Panels shall be Armstrong World Industries: Calla" or equal. Style: 15/16" Tegular Lay-in Suspension System: Wide-face, capped, double-Web Steel.

Keynote #2,

Clarification:

Rooftop Patio Pavers - Basis of Design: Westile – Classic Series Concrete Pavers (24"x24"x2") w/Diamond Finish – Color to be selected by Architect from mfr's standard color options. Or provide equal paver from other mfrs.

Keynote #9,

Change:

Keynote 9 shall read as: Ladder to Roof top: Steel – galvanized and shop primed for field painting.

Keynote #10 & 11,

Clarification:

Keynotes 10 & 11 shall read as: Metal Awnings. Basis of Design: Manufacturer – "Architectural Louvers"

- 1. Fixed, extruded -aluminum exterior sun shade w/ 35 degree fins.
- 2. Standard Trim profile: Rectangular.
- 3. Color: Black
- 4. Finish: 3-coat fluoropolymer.
- 5. Style H6JP8 (provide systems back to back as necessary to provide proper length).

Clarification:

Patio Roof top – Keynote 13: Roof vents shall be redirected to extend up to upper roof within the structure.

Drawing Sheet A-200 – Enlarged Restrooms

Detail 1: Enlarged Restrooms 104 & 105,

Delete:

Delete keynote 8 from these restrooms.

Clarification: integral counter, sink and backsplash of solid surface material to be provided.

Detail 2 & 3: Enlarged Restrooms 121 & 122 / 210 & 211,

Clarification:

Solid surface counter and backsplash w/ drop-in lav, refer to plumbing drawings for lav.



Drawing Sheet A-402 – Wall Sections (typical for all Wall Section Drawings & Detail Drawings)

Wall Section 1, 2 & 3 (Typical for entire building),

Clarification:

Air Barrier Product shall be Commercial Tyvek.

Change:

Exterior wall sheathing shall change from wood sheathing to Dens Glass.

Drawing Sheet A-403 – Wall Sections

Wall Section 3,

Clarification:

Roof System #4: Standing Seam Metal Roof System shall be mechanically attached. Basis of Design: Firestone UNA-CLAD UC-4 self-locking roof panels with minimum 20 year warranty. Or equal product.

Drawing Sheet A-505 – Enlarged Stair Plans

Details 1 & 2,

Clarification:

Stair Treads shall be butcher block style. Species: Walnut. Finish: stain to match doors, waterproof base layer and anti-slip top layer.

Drawing Sheet A-805– Door & Window Details

Change:

All window sills shall change from wood to solid surface material. Basis of Design: Corian - color selections with speckle design or equal product.

Drawing Sheet A-801 – Door Schedule

Door Schedule – Hardware Schedule:

Clarification:

Refer to Door Hardware Specification for correct door / hardware call-offs.

Change:

Door Elevations, Type D3: shall have 5.5" vertical styles and top rail. Bottom shall be 10" high.

Clarification:

Key Note #2 shall read as: Provide 2" conduit from IT rack to Garage & Office building with 6ct OM4 multi-mode fiber.

Clarification:

Key Note #1 shall read as: Provide 2 data cables to each location shown (no voice cables) unless otherwise noted. (typical).

Change:

All Keynotes shown as #2 on plans shall change to #3.

Delete:

Key Note #2 in its entirety.
