## SCOPE OF THIS ADDENDUM

The following becomes a part of the original project manual and drawings, taking precedence over the items that may conflict. The bidder shall note receipt and make acknowledgment of the Addendum on his/her bid form, incorporating its provision in his/her bid.

## **PROJECT MANUAL**

The following additions, changes and clarifications have been made to the Project Manual.

#### Specification Section 08 1113 – Hollow Metal Doors & Frames,

Paragraph 2.3.B,

Add:

2. Exterior Doors shall be 1 hour fire-rated.



#### Specification Section 08 7100 - Door Hardware,

Paragraph 3.5 – Door Hardware Sets,

#### Clarification:

Hardware Sets 1, 2 & 3 shall be minimum of 1 hr fire- rated or as required for FEMA 361 guidelines (whichever is greater).

#### Clarification:

Each Door Hardware set shall be a complete system approved for use with the specific door model provided to meet the FEMA 361 guidelines.

## DRAWINGS

The following additions, changes and clarifications have been made to the Drawings.

#### **Drawing Sheet 7.2 – Exterior Elevations**

Clarification:

Window locations – precast wall at sill shall be chamfered.

#### Drawing Sheet 11.1 – Door, Window & Room Finish Schedules

Window and Frame Schedule

Clarification: W1 Head and Jamb details shall be similar to sill detail (no chamfer at head and jambs).

#### Drawing Sheet 11.2 – Door & Window Details

#### Detail 3/11.2:

Add the following notes to detail 3/11.2:

Frame shall be filled full with grout.

Provide continuous sealant around frame perimeter on interior and exterior.
