Replace 10'0" x 12'0" with **10'0" x 10'0"**

- 1) Specifications Revisions:
 - a) Specification 23 6423, Heat Recovery Chillers
 - i) Add the following under 1.6 Quality Assurance:
 - (1) E. Manufacturer shall have at least two successfully operating heat recovery chillers in the field, operating at a supply temperature at or above 160 F for a period of at least six months. References will be required with shop drawing submittal.
- 2) Drawing Revisions:
 - a) Sheet M-301
 - i) Refer to Detail 7:
 - (1) Note on discharge line coming from SP-4 and SP-5 should be changed from reading "3" HDPE Underground" to "4" HDPE Underground".
 - b) Sheet M-400
 - i) Refer to Storage Tank Schedule:
 - (1) Change HT-1 diameter from 84" to 96". Equivalent epoxy coated steel tank with insulation allowed. Contractor to coordinate tank height with pump length to ensure adequate clearance for pump removal. Coordinate tank height and flanges with door opening size to allow tank to be removed in future.
